19. **The Contract shall be awarded initially for a period from the “Date of Award to 31-05-2023” which is further extendable on yearly basis up to a maximum period of 2-Years on the same terms and conditions subject to the satisfactory performance.**
20. **The contract committee reserves the right to revise the rate of contract (upto 10% of Price-Bid) as per the inflation index while extending the contract. The performance security amount will also be increased accordingly.**
21. Mess Services are to be started from the Date of Award of Contract.
22. **No Junk food item(s)** will be served in the Hostel Mess.
23. The contractor shall execute *Service Agreement* with the college after the **Award of Contract** as per ‘**Annexure-B**’.
24. The successful bidder shall deposit performance security for an amount of **3% of Tender value** in the form of Fixed Deposit Receipts/ Bank Guarantee from any Commercial bank in an acceptable form within 15-days from the date of Award of Contract by the College.

SERVICE AGREEMENT FOR HOSTEL MESS

Agreement between the Principal, Post-Graduate Government College for Girls, Sector-42, Chandigarh and _____, S/o _____ w.e.f. starting date to 31st May, 2023 on the following terms & conditions:-

- a) The successful bidder shall deposit performance security amounting to **3% of Contract Value**, in the form of Fixed Deposit Receipts/ Bank Guarantee from any Commercial bank in an acceptable form within 07-days from the Date of Award of Contract by the College.
- b) That the Contractor will be paid net amount of Mess Bill after deduction of 6.25% as per Annexure-D. The Mess bill will be payable on monthly basis by 10th of every month.
- c) Menu and Schedule of the Meals to be given to the Hostel Resident Students is as per Annexure-C.
- d) **OTHER TERMS AND CONDITIONS:**

1. Only fresh vegetables to be used.
2. No payment will be made during Panjab University notified Winter-Break, Summer-Break or till the start of teaching.
3. **That the Contractor will be paid after deduction of Rs. 6.25% as Maintenance Charges out of total amount collected from the Hostellers and transferred to Mess Fund.**
4. That Income-Tax as per rules applicable to the F.Y. 2022-23 shall be deducted.
5. Any member of the Hostel Welfare Committee can check the meals, tea, etc. for its quality. If any particular meal is not properly cooked or found unfit for consumption by the Committee, the Contractor has to arrange substitute food for the same.
6. That the Contractor will be responsible for the proper maintenance of the utensils, furniture and electrical and electronic gadgets handed over to him by the college Caretaker. The Contractor shall hand over all the articles issued to him at the completion of period of Contract to the college Caretaker.
7. The Contractor is required to keep Wheat Flour, Dals, Sugar, Bread, etc. in covered containers. He is to ensure that only branded Milk, Rice, Atta, Cooking Oil, Tea leaves of good quality are used. **Palm oil and Cotton seed oil will not be allowed to use at any cost.**
8. That no outsider will be allowed to enter the hostel from the kitchen area and dine- in area of the hostel mess without the prior permission of the Principal or Hostel Warden/ Superintendent.
9. That the Contractor will be required to submit the Mess-Bill in the Hostel office, in duplicate by the 3rd of every month duly verified by the concerned Hostel Warden/ Superintendent.
10. That the College can deduct any excess payment made to him from the Mess-Bill/ Performance

Guarantee/ Security Deposit.

11. That the contractor will appoint sufficient number of staff (**at least one female**) to cook & serve the food & to maintain cleanliness and hygienic conditions in and around the kitchen and dine-in area. The hostel mess staff must wear proper uniform provided by the contractor, while on duty. In no case the mess staff should be below the age of 18 years.
12. The Contractor is required to get the medical checkup done of all of his workers and submit their fitness certificates in the office of the Hostel Warden/ Superintendent.
13. The Mess Contractor will get the antecedents of his employees duly verified from the concerned police station *i.e.* Police Station, Sector-36, Chandigarh and give necessary information to the Contract Committee & Hostel Warden/ Superintendent to this effect. Any servant replaced, will be similarly informed to the Hostel Warden/ Superintendent.
14. No Mess staff will be allowed in the Hostel without the Identity Card issued by the Hostel Warden/ Superintendent.
15. The Contractor must have the '**Food License**' from Health Department and will be held responsible for any negligence on his part in preparing meals.
16. Smoking, drinking, intake of drugs by the Contractor or any of his workers is strictly prohibited in Hostel Mess or College campus.
17. The Contractor will use the allotted premises for cooking only. The Mess staff should stay in the designated servant's room only.
18. The Contractor is required to obey the Labour Laws of Government of India and U.T. Administration, Chandigarh.
19. That the Post-Graduate Govt. College for Girls Sector-42, Chandigarh on its part shall not be liable to pay any charges, dues, compensation under any of the disputes to any of the workers which shall be the sole responsibility of the Contractor.
