- 1. That the applicant must have three years relevant experience in any educational institution of tricity (Chandigarh, Panchkula and Mohali).
- 2. Private Shop owners who are in this business can also apply,but their Financial Bid form will be opened only when if sufficient number of applicants are not available as per point number (1).
- 3. If the applicant submit wrong/False/forged documents then he will be responsible at his own and his contract will be terminated immediately and his security will be forfeited and will be black listed in future
- That the above contract is for 11 months i.e. from 1<sup>st</sup> July 2016 to 31<sup>st</sup>
  May, 2017.
- 5. That the contractor will pay **6 months advance rent @1500/- p.m**. at the time of awarding the contract. Rest of the rent of five months will be paid in one installment in the month of December 2016. Contractor will also pay water charges @100 p.m. Photocopy of the receipt of rent/electricity charges must be submitted to the Accountant.
- 6. That the contractor has to deposit Rs.3000/- in form of F.D. in the name of Principal P.G. Govt. College for Girls, Sector-42, Chandigarh as security Deposit before the award of contract. The said security deposit shall be forfeited in favour of college in case of violation of the any terms and condition of the contract. Security will be refunded after the expiry of the contract.
- 7. That the contractor shall not overcharge from the students. In case of any genuine/bonafide complaint, the contractor shall be liable to the penalty as recommended by the contract committee which may lead to cancellation of contract and forfeiture of entire amount of security.
