**TERMS AND CONDITIONS FOR THE CONTRACT OF JUICE/NIMBU PAANI
SHOP FOR THE SESSION 2016-17.**

1. That the applicant must have Minimum three years relevant experience in any educational institution of tricity (Chandigarh, Panchkula and Mohali).
2. **Private Shop owners who are in this business can also apply, but their Financial Bid form will be opened only when if sufficient number of applicants are not available as per point number (1).**
3. **If the applicant submit wrong/False/forged documents then he will be responsible at his own and his contract will be terminated immediately and his security will be forfeited and will be black listed in future**
4. That the contract is for 11 months i.e. from **1st July 2016 to 31st May, 2017.**
5. That the contractor has to pay **6 months advance rent @1500/- p.m.** at the time of awarding the contract. Rest of the rent of five months will be paid in one installment in the month of December 2016. Contractor will also pay water charges @150 p.m.
6. That the contractor has to deposit Rs.3000/- in form of F.D. in the name of Principal P.G. Govt. College for Girls, Sector-42, Chandigarh as security Deposit before the award of contract which will be refunded after the expiry of the contract.
7. **Electricity charges as per Sub Meter reading and as per Chandigarh Administration rate (to be installed by the Contractor at his own cost). In case of Meter not working sum of Rs. 2000/- per month will be charged till faculty meter is replaced/ repaired.**
8. That The contractor shall maintain proper cleanliness of the site and surroundings. Periodic checking will be done by the authorized persons.
9. Quote the rates of following items in Financial Bid Performa 'B'.
 - (a) NIMBU PAANI GLASS (250ml)
 - (b) KINNU JUICE (250ml)
 - (c) ORANGE/MAUSAMI/MIX FRUIT JUICE (250ml)
 - (d) ALL TYPES OF MILK/FRUIT SHAKES (250ml)
 - (e) Sugar Cane Juice (250ml)
8. That the contractor will not add any other item without the prior permission.

9. That the contractor shall display the rates on a board.
10. That the contractor should use good quality steel crockery and maintain proper cleaning of utensils and no sub-standard material is to be used.
11. That the contractor shall not overcharge from the students. In case of any genuine/bonafide complaint, the contractor shall be liable to the penalty as recommended by the contract committee which may lead to cancellation of contract and forfeiture of entire amount of security.
12. That the contractor has to vacate the premises on 31st May, 2017 under all circumstances and all types of dues, charges, rent must be cleared otherwise the contractor will be declared as defaulter by the college authorities in future.
- 13. Initially the contract is for one session, but if the work of the contractor is found satisfactory, on the recommendations of the contract committee, the contract may be renewed for a period of three years (one year at one time, including the present tenure) subject to the approval of competent authority and by increasing the appropriate amount of rent and other charges.**
- 14. That the contractor should get himself and his workers medically examined from the Govt. Hospital.**
15. If the contractor / applicant agrees to said terms and conditions, then signed copy of "Terms and conditions performa" by the applicant/contractor must be submitted alongwith technical performa 'A'.
16. The contractor will execute an agreement with the college regarding the said contract.
