## TERMS AND CONDITIONS FOR HEALTH AND SKIN CARE 2016-17

- 1. That the applicant must have three years Relevant experience in any educational institution of tricity (Chandigarh, Panchkula and Mohali).

- 9. That the contractor has to deposit Rs.5000/- in form of F.D. in the name of Principal P.G. Govt. College for Girls, Sector-42, Chandigarh or as per latest instructions as security Deposit before the award of contract. The said security deposit shall be forfeited in favour of college in case of violation of the any terms and condition of the contract. Security will be refunded after the expiry of the contract
- 10. That he/she will have to pay 6 months advance rent (Rs 1750x 6 = Rs. 10500/-) to be paid at the time of awarding the contract. Rest of the rent of five months will be paid in one installment in the month of Dec,

2016 and the photocopy of the receipt of rent and electricity charges must be submitted to the Accountant.

- 11. That the contract can be terminated at any time if some gross violation of terms and condition, misbehavior, misconduct, overcharging and substandard norms are noticed and the security deposit are also liable to be forfeited.
