**TERMS AND CONDITIONS FOR WASHERMAN / WASHERWOMEN  
CONTRACT FOR THE SESSION 2016-17 (For Hostel resident of PGGCG-42  
& Sector 24 Hostel)**

Experience	Minimum three years relevant experience in any educational institution of tricity (Chandigarh, Panchkula and Mohali)
Time Period	1 <sup>st</sup> July 2016 to 31 <sup>st</sup> May, 2017.
Rent	Rs. 1000/- per month
Water Charges	Rs. 500/- per month
Security	Rs. 3000/- in form of F.D. in the name of Principal P.G. Govt. College for Girls, Sector-42, Chandigarh to be submitted on the award of the contract. Security will be refunded after the expiry of the contract.

1. That the contractor will pay 6 months advance rent and water charges (to be paid at the time of award of the contract). Rest of the rent of five months will be paid in one installment in Dec, 2016 ( If applicable). Receipt of rent and Electricity charges must be submitted to the Accountant.
2. That the contractor will charge half month charges for the month of July 2016, from the resident whose stays during these months.
3. Any damage to the cloth of residents during washing and ironing will be borne by the contractor.
4. No electricity connection will be provided by the college authorities. The contractor has to do all the work of washing and ironing manually.
5. That the decision of the Contract Committee will be final and binding to all the applicants.
6. **Initially the contract is for one session, but if the work of the contractor is found satisfactory, on the recommendations of the contract committee, the contract may be renewed for a period of three years (one year at one time, including the present tenure) subject to the approval of competent authority and by increasing the appropriate amount of rent and other charges.**

7. Quote the rates of following items in Financial Bid Performa 'B'.

(In sealed envelope).

- (a) Washing and ironing per month per resident (for first 15 clothes of any regular size (blankets/bed sheets not inclusive).
- (b) Ironing per cloth
- (c) Washing and Ironing per cloth
- (d) Blanket Single/Double Washing and Ironing
- (e) Bed Sheet Single/Double Washing and Ironing

8. If the contractor / applicant agrees to said terms and conditions, then signed copy of "Terms and conditions performa" by the applicant/ contractor must be submitted alongwith technical performa 'A'.

9. The contractor will execute an agreement with the college regarding the said contract.
