- 5. 'Technical-Bid' Proforma for technical evaluation of the bidder is at Annexure-E.

- 14. Rates approved for Mess charges shall be applicable as per weekly **Menu** given at 'Annexure-F'.

- 16. The Tender shall be opened in the Office of Principal, P.G.G.C.G.-42, Chandigarh as per GeM schedule. In the event of the last date of opening of tender being a holiday or being declared as holiday, the last date of opening of the tender shall be the next working day at the same time and venue.
- 17. Only those Applicants will be considered/ shortlisted who have minimum **Three-Years** of Experience in the last 5-Years of serving the North-Indian cuisine (Breakfast, Lunch and Dinner) to at least 100 students in the Hostel Mess of any College under Chandigarh Administration or any other Government or Private Educational Institutions. Experience Certificate(s) in this regard issued by the served institutions are also required to be submitted online.

Past Experience of similar Services: The bidder must have successfully executed/ completed at least One-order of 80% of the Estimated Bid value, Two-orders each of 50% of the Estimated Bid value or Three-orders each of 40% of the Estimated Bid value for similar service(s) in last three years in any Central/ State Govt. Organization/ PSU/ Public Ltd. Company. Copies of contracts/ Work Order and relevant documentary evidence of successful execution/ completion in support of past experience of similar services along with Name(s), Address and Contact details of all the Clients shall be uploaded with the bid for verification by the Buyer.

- 18. Assignment of Contract or Subletting of Hostel Mess Premise to any 3rd party is not allowed under any circumstances. The Bidder must furnish the valid Income Tax/ PAN/ GST Number.
- 19. The Contract shall be awarded initially for a period from the "01-10-2024 to 31-05-2025" which is further extendable on yearly basis up to a maximum period of another One-Year on the same Terms and Conditions at the discretion of the Institution.
- 20. The contract committee reserves the right to revise the rate of contract (upto 10% of Price-Bid) as per the Inflation-Index while extending the contract further. The performance bank guarantee (ePBG) amount will also be increased accordingly.
- 21. Mess Services are to be started from the **Date of Award of Contract**.
- 22. The Mess Contractor shall arrange Cooking and Serving utensils including Deep-freezer, Refrigerator, etc. on its own. **No Junk-Food item(s)** to be served in the Hostel Mess.
- 23. The successful bidder shall deposit **EMD** (shall be of the value of **2%** of contract value, where it is applicable) and performance bank guarantee (**ePBG**) for an amount of **5% of Contract-Value** (with a validity of 60 days beyond the date of termination of contract) in the form of Fixed Deposit Receipts/ Bank Guarantee from any Commercial Bank (within Chandigarh) in an acceptable form within **15-days from the Date of Award of Contract** by the College, **failing which appropriate action will be taken against the bidder**.
- 24. The *Service Agreement* shall be made/ executed at Chandigarh by the contractor with the college authority as per 'Annexure-B'. In the event of any dispute related to the interpretation of rights or liabilities arising out of this agreement, the same shall, at first instance, be amicably settled between the parties. In case dispute is not settled then the matter shall be referred to the Contract Committee whose decision shall be final and binding upon both the parties. All legal matters related to the Contract shall be limited to **Chandigarh Jurisdiction** only.
- 25. The Contractor shall not sell any tobacco products, alcoholic product and drugs of any type, prohibited items, as laid down in the Law.
- 26. Seller must attach a copy of **Food License** under PFA and FSSAI obtained from Government Health Department.
- 27. In case of repeated violation of Terms & Conditions as mentioned above and mentioned in the service agreement, the awarded Contract will be terminated and the security will be forfeited.

- a) The successful bidder shall deposit **EMD** (shall be of the value of 2% of contract value, where it is applicable) and Performance Bank Guarantee (ePBG) amounting to 5% of Contract Value (with a validity of 60 days beyond the date of termination of contract), in the form of Fixed Deposit Receipts/Bank Guarantee from any Commercial bank (within Chandigarh) in an acceptable form within 15-days from the Date of Award of Contract by the College.
- **b**) After acceptance of Contract offer or after signing of agreement if the Firm/ Individual fail to start the Hostel Mess within 10 days, the contracts can be cancelled and the Earnest money/ Security money shall be forfeited.
- c) That the Contractor will be required to submit the Mess-Bill (inclusive of GST) in the Hostel Office in duplicate by the 3rd of every month duly verified by the concerned Hostel Warden/ Superintendent
- d) That Contractor will be paid net amount of the Mess-Bill (after deduction of **6.25%** as per **Annexure-D**) on monthly basis by **10**th of every month (subject to revision as per Central Govt. rules).
- e) Menu and Schedule of the Meals to be given to the Hostel Resident Students is as per Annexure-C.

f) ADDITIONAL TERMS & CONDITIONS (ATCs):

- 1. Only fresh vegetables to be used.
- 2. No payment will be made during Panjab University notified Winter-Break and Summer-Break.
- 3. During December and May Final Semester Examinations, in case the Student Vacates the Hostel before 15th of the respective month, she will pay mess charges for 15 days only. But if the student leaves the hostel after 15th then she will pay for additional number of days she stays in the hostel before the start of Panjab University notified winter and summer vacations.
- 4. That the Income-Tax (TDS) and GST as per the rules applicable to F.Y. 2024-25 shall be deducted.
- 5. Any member of the "*Hostel Welfare*" Committee can check the meals, tea, etc. for its quality. If any particular meal is not properly cooked or found unfit for consumption by the Committee, the Contractor has to arrange substitute food for the same.
- 6. The Contractor will be responsible for the proper maintenance of the furniture, electrical and electronic gadgets handed over to him by the college Caretaker. The Contractor shall hand over all the articles issued to him at the completion of period of Contract to the college Caretaker in perfect working condition (except normal wear and tear), failing which the institute will be at

- liberty to recover the cost of all such damages caused to the equipment(s) from the contractor's refundable security deposit.
- 7. The Contractor is required to keep Wheat Flour, Dals, Sugar, Bread, etc. in the covered containers. He is to ensure that only branded Milk, Rice, Atta, Cooking Oils, Spices and Tea leaves of good quality are used. "Palm oil or Cotton-seed oil will not be allowed to use at any cost".
- 8. Lunch and Dinner should consist of seasonal vegetables in the menu.
- 9. No outsiders will be allowed to enter the Hostel-mess from the Kitchen area or Dine-in area without prior permission of the Principal or Hostel Warden or Superintendent.
- 10. That the College can deduct any excess payment made to him from the subsequent Mess-Bill/ Performance Bank Guarantee/ Security Deposit.
- 11. That the contractor will appoint sufficient number of staff to cook & serve the food. Presence of **One Female Staff** is mandatory at the time of serving.
- 12. A Complaint Book (for the hostel residents) is to be maintained and submitted to the Hostel Warden Office for its scrutiny, on daily basis.
- 13. <u>CLEANLINESS</u>: It shall be the responsibility of the Contractor to employ adequate number of cleaners and sweepers and provide them with adequate and necessary equipment's/ materials for keeping the kitchen and dining area properly cleaned. Anti-Rodents and Pest-Control measures will also be strictly followed and it will be the responsibility of the Contractor to ensure that the premise is free from these and no college support staff or sweeper will be provided for this purpose.
- 14. All Hostel-Mess Staff must wear proper uniform (head-cap, gloves, kitchen-apron, etc.) and also must have their **Identity-Card** provided by the contractor, while on duty. In any case the Mess Staff should not be below the age of 18 years. A list of all employed staff should be submitted to the Principal.
- 15. The Contractor is required to get the medical checkup done of all of his workers and submit their fitness certificates in the office of the Hostel Warden/ Superintendant.
- 16. The Mess Contractor will get the antecedents of his employees duly verified from the concerned police station *i.e.*, Police Station, Sector-36, Chandigarh and give list of employees to the college authorities. Any servant replaced, will be similarly informed to the college authorities.
- 17. The Contractor must have the '*FOOD LICENSE*' (FSSAI) issued by Competent Authority and will be held responsible for any negligence on his part in preparing meals.
- 18. Smoking, drinking, intake of drugs by the Contractor or any of his workers is strictly prohibited in Hostel Mess or College campus.
- 19. The Contractor will use the allotted premises for cooking only. The Mess staff should stay in the designated servant's room only.
- 20. After completion of this contract, it shall be the duty of contractor to remove all the persons

- deployed by him and ensure that no person creates any disruption/ hindrance/ problem of any nature.
- 21. The Contractor is required to submit Labour License, if applicable (within 30 days from the Start of Contract) and obey all the Labour Laws of Government of India and U.T. Administration, Chandigarh.
- 22. Liability/ responsibility in case of any fire accident or any other accident-causing injury/ death to mess workers/ in-maids or any of his staff shall be that of the employer. The College authorities shall not be responsible or liable to pay any compensation/ dues/ charges in such cases.
- 23. The Contract shall be awarded initially for a period from the "01-10-2024 to 31-05-2025" which is further extendable on yearly basis up to a maximum period of 2-Years (one year at a time) on the same terms and conditions at the discretion of the Institution.
- 24. The awarded contract will be for serving meals to 130 hostel residents with 25% increase or decrease of students during the session.
- 25. The Contract committee reserves the right to revise the rate of contract (upto 10% of Bid-Price) as per the Inflation-index while extending the contract. The performance security amount will also be increased accordingly.
- 26. The *Service Agreement* shall be made/ executed at Chandigarh by the Contractor with the college authority as per **Annexure-B.** In the event of any dispute, the decision of the Contract Committee shall be final.
- 27. Bidder must have their Residential Address or Head/ Branch Office in the Tri-city (Chandigarh/ Mohali/ Panchkula).
- 28. All legal matters relating to Contract shall be limited to **Chandigarh Jurisdiction** only.
